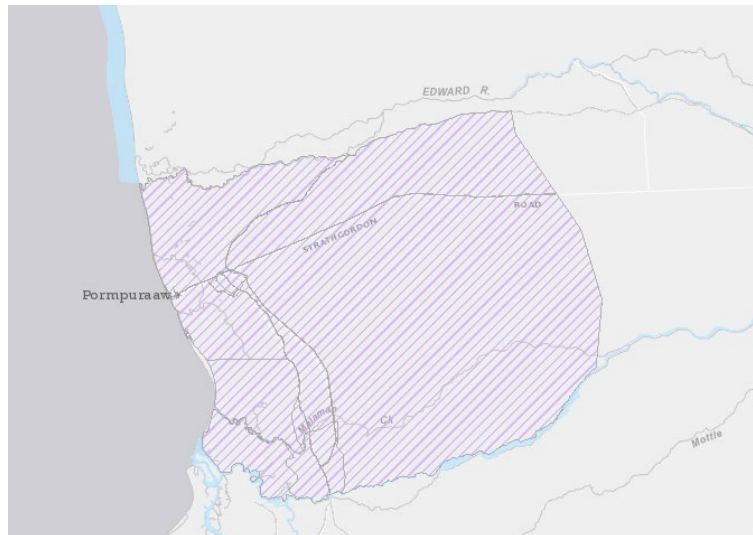


**RE-SCHEDULED NOTICE OF
AUTHORISATION MEETING FOR A
NATIVE TITLE DETERMINATION AGREEMENT**
Edward to the Coleman Rivers, Western Cape York
Cape York United Number 1 Native Title Claim (QUD673/2014)

Cape York Land Council (CYLC) has re-scheduled this authorisation meeting due to COVID-19 restrictions that will apply to 22 August 2021 preventing necessary pre-engagement with Traditional Owners. CYLC will hold the re-scheduled meetings on **1 and 2 September 2021** in **Kowanyama and Pormpuraaw** to consider whether to authorise a proposed agreement for a determination of native title for that area between the Edward and Coleman Rivers, Western Cape York, shown on the map below.



A determination of native title involves a decision of the Federal Court. Important things about a determination of native title include that the Federal Court determines (1) who holds native title, (2) what the native title rights are, (3) the area to which the native title rights apply after any determination is made, and (4) which corporation will represent the determined native title holders. If the meetings on 1 and 2 September 2021 authorise the proposed determination of native title, the determination will then be sought in the Federal Court. The Court has listed a hearing for a potential consent determination for that area between the Edward and Coleman Rivers shown on the map above, if there is to be a consent determination, on **23 November 2021**.

A copy of the proposed agreement for a determination of native title for that area between the Edward and Coleman Rivers shown on the map above will be available at each meeting on **1 and 2 September 2021**. At the request of the people who constitute the Applicant in the Cape York United Number 1 Native Title Claim, CYLC staff and consultants will be in attendance to be available to explain things such as the meaning and effect of the proposed agreement at each meeting. Any person attending a meeting will be able to ask questions about the proposed agreement and state their views about it.

Who is invited to attend the meetings?

The meeting is open to all descendants by birth, or adoption in accordance with traditional law and custom, of one or more of the following apical ancestors:

If you would like CYLC to arrange a video-conference from your location, whether you live at the location of a meeting (Kowanyama or Pormpuraaw) or elsewhere, into either or both of the meetings please contact CYLC on the number below. Attendance by video-conferencing facilities is offered because of, among other things, the potential for the COVID-19 emergency to interfere with potential attendance. It is important to provide every opportunity for persons entitled to attend the meetings to attend.

Purpose of the Authorisation Meetings

The purpose of the meetings is to decide whether or not to approve the proposed agreement for a determination of native title for the area between the Edward and Coleman Rivers. The agenda of each meeting will be to consider whether the persons present:

- agree and adopt a decision-making process;
- agree to the proposed agreement for a determination of native title;
- decide to incorporate a proposed corporation to represent the native title holders identified in the proposed agreement for a determination of native title;
- if a decision is made to incorporate the proposed corporation, make a decision (1) to approve the rules of the proposed corporation, (2) to identify who will be the initial directors and contract person for the proposed corporation, and (3) to authorise one or more named persons to apply to the Office of the Registrar of Indigenous Corporations to register the proposed corporation;
- agree to nominate the proposed corporation, once it is registered, to be the corporation to represent the native title holders identified in the proposed agreement for a determination of native title (called a “prescribed body corporate”);
- authorise the Principal Legal Officer of CYLC to nominate the proposed corporation, once it is registered, in writing to the Federal Court for it to be the prescribed body corporate under s.57(2)(a)&(b) of the *Native Title Act 1993* (Cth) for the proposed determination of native title.
