NOTICE OF CONSULTATION


EPM 28626 – Abercrombie Resources Pty Ltd Northern Cape York #2 Native Title Group Monday 26 August 2024

This notice is to advise that CYLC will facilitate a meeting with people who hold Native Title rights and interests in the proposed Exploration Permit for Minerals (**EPM**) 28626 (as shown on the map below). On 9 August 2023, the Department of Resources issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying that EPM 28626 is an act that attracts the expedited procedure. Mokwiri AC RNTBC objected to the expedited statement on 4 December 2023.
