#### Cape York United #1 Native Title Claim (QUD673/2014)

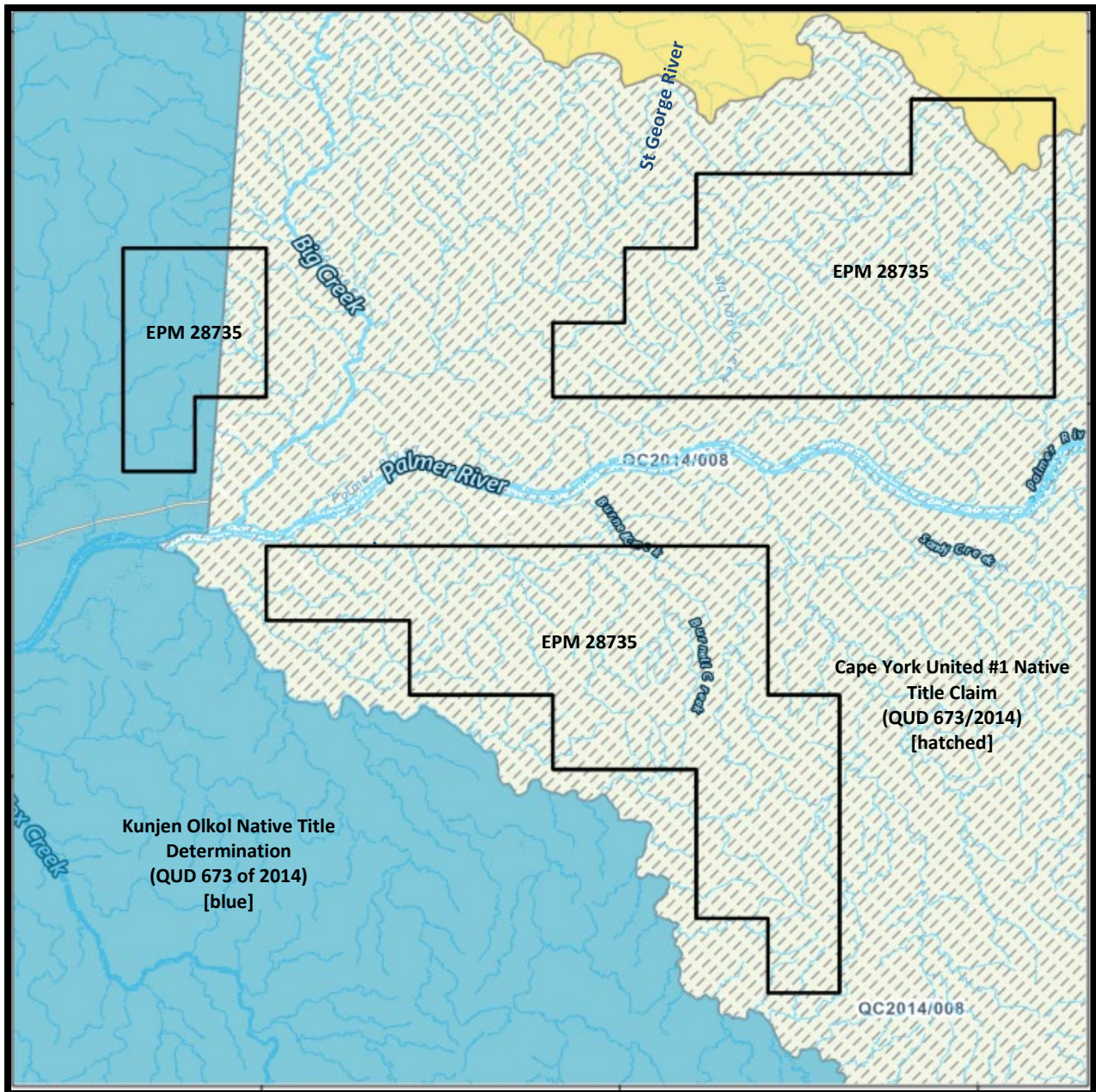
On 17 July 2024, the State of Queensland issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) identifying that proposed Exploration Permit for Minerals (EPM) 28735 is an act attracting the expedited procedure.
