NOTICE OF CONSULTATION

EPM 28735 - EPM 28758 - Ark Mines Ltd

Possum Native Title Determination (QUD 673 of 2014)

On 17 July 2024 and 28 August 2024, the State of Queensland issued a notification under section 29(7) of the *Native Title Act 1993* (Cth) (**NTA**) identifying that proposed Exploration Permits for Minerals (**EPMs**) 28735 and 28748 are acts attracting the expedited procedure.

This notice is to advise that Cape York Land Council (**CYLC**) will facilitate a meeting with those people who hold Native Title rights and interests within the Possum Native Title Determination (QUD 673 of 2014) subject to the proposed grant of:

- 1. EPM 28735 held by Ark Mines Ltd (as shown on the map below in red);


