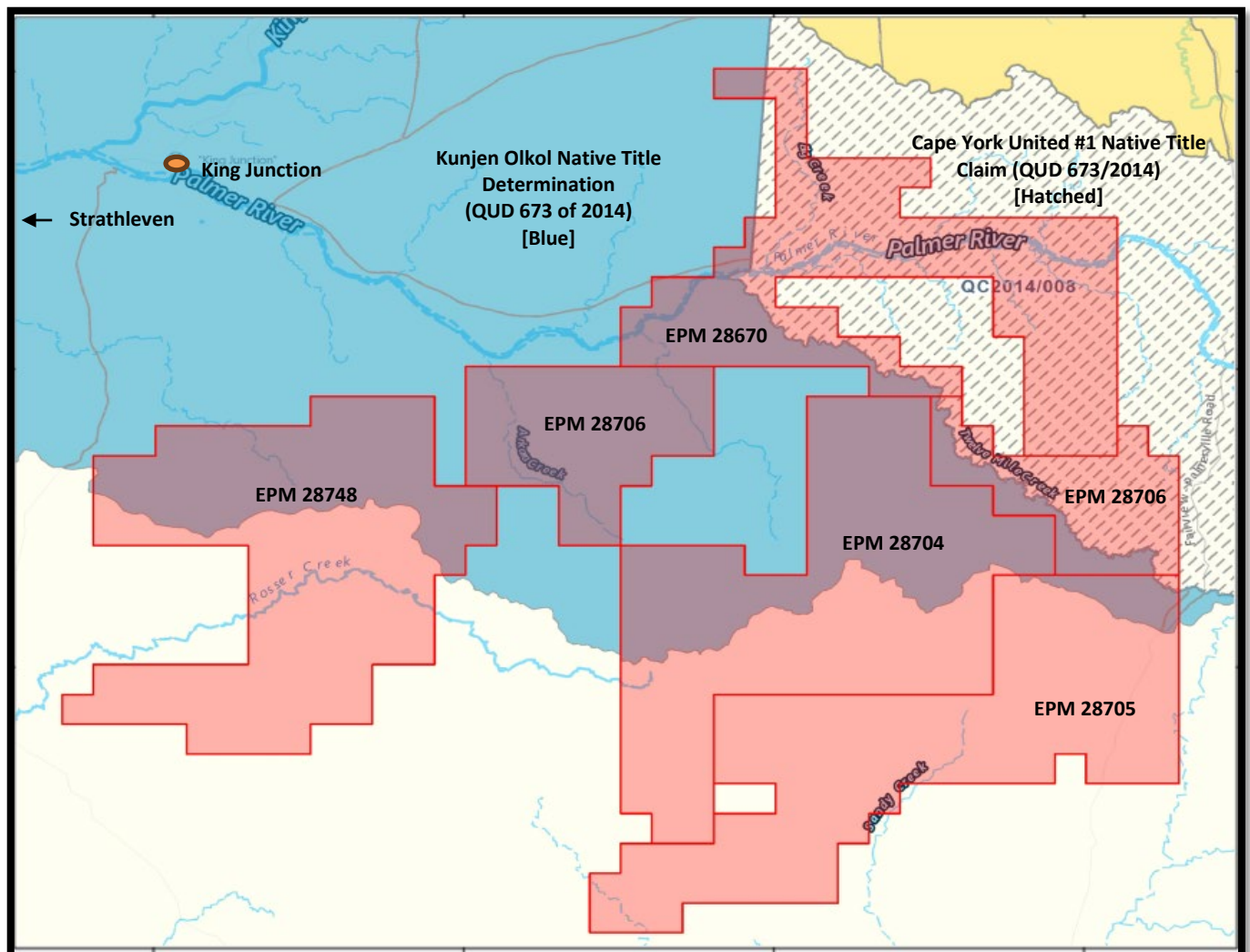
The Explorer has commenced full enquiry proceedings with the National Native Title Tribunal (NNTT) with a view to receiving a determination that the expedited procedure applies to EPMs 28670, 28704, 28705, 28706 and 28748.

On 20 December 2024, CYLC facilitated a meeting to discuss the NNTTs full enquiry process and options available to progress this matter. At this meeting, it was agreed that the Native Title Holders would attend a meeting in January 2025 to discuss the progression of the matter.
