
Kunjen Olkol Native Title Determination (QUD 673 of 2014)

This notice is to advise that Cape York Land Council (**CYLC**) will facilitate a meeting with those people who hold Native Title rights and interests within the Kunjen Olkol Native Title Determination (QUD 673 of 2014) subject to the proposed grant of Mining Leases (**MLs**) 100321, 100322 and 100323 held by Aurum Vale Pty Ltd. The Mining Leases were originally notified on 12 October 2022, and then subsequently re-notified on 24 April 2024, under s. 29 of the *Native Title Act 1993* (Cth) (**NTA**) and are subject to the right to negotiate under s. 31 of the NTA.
